Competitions (part)

- The knockout entry fee is £1.50 per player. Anyone who has not registered in person by 8.00pm sharp will not be allowed entry into a knockout. (Subject to committees' discretion).
- Anyone who cannot register in person by 8.00pm and wishes to enter the knockout will need to contact a committee member personally beforehand to be placed in the draw. They must then be at the venue by 8.30pm at the latest and inform the knockout steward when they arrive, or they will be removed from the draw, and risk being ruled out of further competitions. (Subject to committees' discretion).
